Tom ROE is an adviser on international relations and Senior Vice President at the EU-ASIA Centre in Brussels www.eu-asiacentre.eu. From 1980 until December 2012 ROE was a full-time official of the European Union working on Europe's external relations worldwide. An Asia expert, from 2002-2012 ROE was Adviser to the Asia and Pacific Department of the European External Action Service in Brussels including postings in Asia as EU Head of Mission in Hong Kong 2004-2008 and as EU Fellow at the Lee Kuan Yew School of Public Policy Singapore 2010-2011.¹ He has also been a Visiting Professor at various universities in Europe, Asia and the USA teaching postgraduates on; the European Union, the European Single Market, European Foreign Policy, Globalization, National Identity and Governance, and Development Policy.

Tom ROE's research and teaching interests are Asia, European Union external policies, global governance, regional integration, and nationality and identity. He has been a Visiting Professor at London Business School, the Open University UK, George Mason University USA, Hong Kong University, the Lee Kuan Yew School of Public Policy Singapore and is now a Visiting Practitioner Fellow at the Ason Centre for Europe at Aston University UK and a Visiting Scholar (Maitre d'Enseignement) at the Institute for European Studies at the Universite Libre de Bruxelles, as well as being Senior Vice President at the EU-ASIA Centre in Brussels.

Roe has two Bachelors degrees both with First Class Honours in Economics (University College London) and in Post-Colonial Studies (Open University UK) as well as two Masters degrees - an MBA (London Business School) and a research Masters degree with high distinction from the Open University UK. His thesis research topic was "Tropes of Individual and National Identity in V.S. Naipaul's Fiction". Roe was a Kennedy Scholar 1973-74 in international economics at the Kennedy School of Government at Harvard University, and visiting IMP scholar at Hautes Etudes Commerciales France 1978 and New York University Stern Business School 1979. Before joining the European Union he was a management consultant with McKinsey & Company London 1979-1980 and an international banker with Lloyds Bank International in Paris, London, Bahrain and Dubai 1974-77. ROE speaks fluent French. His mother tongue is London English. Tom ROE was born in central London and is now based in London and Brussels.
